The sad truth is, in 2021 the United States saw the highest number of abortion restrictions made law in a single year and given everything we know about the pipeline of cases at the Supreme Court, those numbers will only grow in years to come. But while we watch the continued attacks on abortion rights across the country, they are thankfully strong here in Maryland. The Maryland legislature has vigilantly and successfully defended against an onslaught of attempts to chip away at those rights over the past several decades. Unfortunately, that has only emboldened abortion opponents who have filed over a dozen bills this session in an attempt to prevent women from making their own decisions and receiving the reproductive health care they need and deserve.

In short, those bills make it clear that some legislators do not trust women.

But we know that by trusting women, we are empowering them to make the best decisions for themselves and their families. And this week, the WLC will be standing strong with partner organizations in opposition to the litany of bills that all share one purpose: taking away a woman's right to abortion care.

At the same time, I am happy to report that HB937 - the Abortion Care Access Act, and HB1171 - Declaration of Rights - Right to Reproductive Liberty (which would create a constitutional amendment protecting reproductive rights in Maryland) both passed out of the Health and Government Operations Committee this week. The following are anti-choice bills being heard this week in the Health and Government Operations Committee:

HB1213 Human Services - Commission on Fatherhood (Fatherhood Protection Act) - while not directly related to abortion rights, It is an unfortunate irony that House Bill 1213 is once again being heard during a month that should otherwise be spent galvanizing the movement towards gender equity, as the bill is nothing short of a mockery of the progress that has been made throughout the years.

HB1360 Public Health - Abortion-Inducing Drugs

HB1364 Health Care Freedom of Conscience Act

In addition to the anti-abortion bills being heard this week, the WLC is happy to be supporting some important pieces of legislation:

SB776 Correctional Services – Pregnancy and Postpartum Support (Prevention of Forced Infant Separation Act). As women continue to be incarcerated at a higher rate than men, and most incarcerated women are single mothers, it is important that our policies be updated to reflect the

different needs of incarcerated women. This legislation, modeled after successful programs in other jurisdictions, allows the newborn infants of incarcerated women to stay with them, rather than be forcibly separated at

HB1168/SB849 - Child Custody - Legal Decision-Making and Parenting Time - the House and Senate are both hearing this bill on Thursday this week. This bill would provide a much needed overhaul and update to our custody laws in Maryland, codifying existing Maryland case law regarding custody determinations using the best interests of the child standard. It is the revised product of a more than one year Child Custody Decision-Making Commission on which the WLC participated.
