So far, of the more than 170 bills we have been monitoring, 9 have already been passed by the general assembly and are headed to the Governor's desk. And we know that number will continue to grow. While we hope that everything sails smoothly through to passage, it is inevitable that some bills will get stuck along the way. Keep an eye on your inbox for alerts over the next few days for specific pieces of legislation that might need an extra push.

We have made it this far together and we cannot wait to celebrate with everyone at the end. In the meantime, thank you so much for all your support and advocacy these past 90 days. Together, we can ensure our laws work to ensure the physical safety, economic security, and bodily autonomy of women in Maryland!
