


# **Celebrating 53 Years of Advancing Justice**

# What's happening in Annapolis this week?

The legislative session started on January 10th! The last four weeks have been full of incredible work from the movers and changemakers championing Women's Rights - our amazing partners!

Check out some incredible bills being heard this week to make a difference for Maryland women!

## Tuesday February 6th:



The Women's Law Center of Maryland supports HB301

HB301 Correctional Services- Diminution of a Term of Confinement- First -Degree rape and First-Degree Sexual Offense (The Pava Marie LePere Act)

will prohibit a person convicted of a first-degree rape and a first-degree sexual offense from being entitled to diminution of the incarcerated individual's term of confinement. An incarcerated person convicted of these two specific crimes will still be eligible for release by the Parole

Commission. This bill will end the existing law which allows for the mandatory release of these violent sex offenses.

HB575 Criminal Procedure-

#### Victim Compensation-Alterations (Victim Compensation Reform Act of 2024)

will create an accessible, nondiscriminatory victim compensation process to support all victims of crime or their family members left behind. It will provide prompt and crucial financial support when needed most and remove unnecessary and arbitrary denials of financial relief for applicants for expenses incurred because of being a victim of crime. This bill also eliminates the




requirement that a victim report a crime within 48 hours (about two days) and that the victim must fully cooperate with law enforcement. Lastly, the bill reconstitutes the Criminal Injuries Compensation Board to include more members with lived experiences and members who work directly with victims.

The Women's Law Center of Maryland supports SB0071.

### <u>SB0071 Correctional</u> <u>Services- Pregnancy and</u> <u>Postpartum Support</u> (Prevention of Forced Infant Separation Act)

will create the Healthy Start Bonding Program within the Maryland correctional system, which will allow women who are on prerelease status and who have recently given birth to reside with their child in the prerelease unit for up to a year following the birth of their child. Currently, most incarcerated

women have less than 48 hours (about two days) with their newborns before the baby is forcibly separated from their mother.

#### HB 330 Strategic Lawsuits Against Public Participation (SLAPP)

clarifies the exercise of Constitutional Rights to petition the Courts and exercise free speech by amending the existing law regarding SLAPP suits. SLAPP suits intentionally target survivors, whistleblowers, and advocates who speak out against powerful perpetrators, creating a chilling effect on other victims who may want to speak out to do the same. HB330 will prevent litigation abuse. By curbing litigation abuse and safeguarding individuals who speak out against powerful perpetrators, HB330 aligns with our mission to empower and advocate for survivors.
